



## Tioga County Foundations Coalition Emergency Fund Serving Tioga County, New York

These grants are intended to help Tioga County respond to the challenges caused by the COVID-19 pandemic by addressing the urgent operating and unmet programmatic needs of organizations providing essential services in Tioga County, New York. An Advisory Committee comprised of representatives affiliated with the Tioga County Foundations Coalition will review applications, and funds will be released on a rolling basis as fundraising continues throughout the outbreak and recovery phases of the crisis. Because this is an evolving situation, these will be rapid-response, short-term grants (up to 4 weeks of funding).

Grants are limited to 501(c)3 organizations, fiscal sponsors or other charitable organizations able to receive tax-deductible contributions such as schools, faith-based organizations and other public entities.

Priority will be given to applications that demonstrate a response to current unmet essential needs directly related to the COVID-19 crisis.

The minimum award will be \$1,000 and the maximum award will be \$10,000.

Applications will be reviewed every Thursday. You must submit a completed application by noon on Monday if you want the application to be reviewed on Thursday, otherwise it will roll into the following week.

Awards will be paid out upon receipt of the executed grant contract.

Applicants must agree to the following:

1. Address an urgent, essential unmet community need
2. Demonstrate that their continued operation is critical to meeting urgent COVID-19 related needs in the County
3. Serve vulnerable populations (especially in under-served communities)
4. Commit to documenting services provided and impact
5. Provide back-up on how funds were spent
