Local Law No. 3 of 2022 authorized the County to impose an additional \$1.00 surcharge for telephonic communication to pay for the costs associated with obtaining, operating and maintaining the telecommunication equipment and telephone services needed to provide an enhanced 911 emergency telephone system (E911) to serve Tioga. The additional surcharge of \$1.00 will be applied to the current surcharges for both wireless and traditional telephone services for a period of ten years. For monthly wireless devices, the new surcharge is \$1.30 and for traditional telephone providers and Voice Over IP (VOIP) services, the new surcharge is \$1.35. Ms. Haskell reported the collection start date was June 1, 2022. This local law will expire and be deemed repealed August 31, 2031.

## **Outstanding Financial Disclosures:**

All Legislators submitted their 2022 financial disclosures to the County Attorney's office.

## NeoGov Account Activation:

Ms. Haskell reported this is the new platform that will be used for all future required County trainings. Although there are no required trainings due at this time, Legislators are encouraged to activate their accounts. Christine Freyvogel, Secretary to the County Attorney, emailed account activation links to all Legislators and is available by phone or inperson to offer assistance, if needed.

## 2022 Legislative Clerk Conference:

Ms. Haskell reported she attended the Legislative Clerk's conference last month in Cattaraugus County. Ms. Haskell reported this is the 2<sup>nd</sup> year she has attended this conference and noted it is a great venue for networking with other fellow Legislative Clerks. Ms. Haskell reported NYSAC Executive Director Acquario, Deputy Director LaVigne, and Attorney Cummings provided an Albany Update that included topics such as Opioid settlement and 18b Assigned Counsel pending litigation that County Attorney DeWind has been keeping the Legislature up to date. In addition, NYSAC is continuing to push for permanency on the sales tax extender to eliminate the Home Rule Request process, but there has been no change to date.

June 2022 Legislative Meeting - The Sixth Regular Legislature meeting will be held on Tuesday, June 14, 2022, at 12:00 p.m. with Finance, Legal, and Safety Committee meeting just prior at 10:30 a.m. Legislator Mullen will lead the Legislature in the prayer, pledge, and voting process.

Legislature Meeting along with Commissioner of Public Works Hammond. Legislator Weston will read and present this recognition resolution.

There is one (1) proclamation; **Skin Cancer Awareness Month**, which will be noted in the minutes, as this proclamation has been read and presented in year's past.

Legislator Standinger expressed an interest in serving on the Tioga County Council of Government (COG), as there has been no Legislative representation since former Legislator Sullivan's retirement effective December 31, 2022. Chair Sauerbrey will appoint Legislator Standinger to the Tioga County Council of Government at the June 14,, 2022 Legislature meeting.
