# **NEW BUSINESS**

**2022 Leadership Tioga Graduation –** Ms. Haskell thanked the Legislature for the opportunity to attend this year's program. Ms. Haskell reported she attended all eleven (11) monthly meetings across the County with graduation commencement held yesterday.

**Cybersecurity Training** - Ms. Haskell reminded the Legislators that the required cybersecurity training needs to be completed by November 18, 2022. Ms. Haskell reported all Legislators should have received an email from either Charles Root, IT Department, or directly from KnowBe4.

**2023 Flex Spending Enrollment –** Ms. Haskell reminded the Legislators that the 2023 Flex Spending Enrollment is currently open, and paperwork must be submitted to Benefits Manager Poff by December 2, 2022. This is a program that you must enroll in every year.

**Dental/Vision Open Enrollment** – Ms. Haskell reminded the Legislators the dental/vision enrollment is currently open for 2023 and those currently participating in this benefit do not need to re-enroll providing they are maintaining the same level of coverage. Any changes would require new enrollment with Benefits Manager Poff before 12/2/22.

**Annual Trainings** – Ms. Haskell reported the Law Department sent links via email to all Legislators to complete the annual safety, workplace violence, Title VI, and discrimination and harassment trainings via NeoGov (NYMIR).
